Furthermore, we ensure that our related entities, our advisers, members of governing and supervising bodies (ours and our related entities'), as well as persons being bound by an employment contract, mandate contract or any legal relation of a similar nature with us or our related entities, shall not disclose confidential information to any third party and shall use them solely for the purposes connected with our participation in the Procedure. Furthermore, we undertake that without having obtained the prior consent of PPL neither we nor the above-mentioned entities shall make notifications/notices on our participation in the Procedure, including the choice of our offer as most advantageous or that we do not participate in the Procedure any more for whatever reason. In the case of the breach of the above obligations we acknowledge that we shall incur liability arising out of the provisions of the law applicable in this respect and we undertake to cover any damage resulting from such breach.
